## First anniversary of the French Act on prostitution and human trafficking: a progressive law becoming reality !

In April 2016, after a three year cross-party parliamentary process, France fully remodeled its public policies in relation to prostitution and trafficking in human beings.

**The Law of the 13th of April 2016, Aiming to Strengthen the Fight Against the Prostitution System and to Assist Prostituted Persons** has :

- Decriminalised prostituted persons
- Reinforced the State's protection for victims of pimping and trafficking in human beings
- Offered access to protection's residency permits for foreign victims of trafficking
- Set up a national « exit policy » and developed new victims rights
- Recognised as a form of violence, and criminalised, the purchase of sex
- Established national standards for harm reduction, prevention and education, and training of professionals

**Only one year after the adoption of the law, France has immediately implemented:**

- Effective end to the arrests of prostituted persons for solicitation
- 937 sex buyers arrested and fined
- Recognition of physical and sexual violence against a prostituted person as an aggravating circumstance, which has been used in several trials

**The implementation of the social chapters** of the law first required the publication of ministerial decrees. To date, **4 implementation decrees** (out of 5) have already been published :

- On the implementation of the national « exit policy »
- On harm reduction in relation to physical and psychological health
- On access to residency permits for foreign victims
- On the implementation of the mandatory awareness courses for sex buyers

**French members of CAP international, Mouvement du Nid and Fondation Scelles, together with the 60 member organisations of the collective Abolition 2012, are now prioritising the effective implementation of newly recognised rights for victims of prostitution and trafficking:**

- Legal, psychological and medical support,
- Access to exit programmes,
- Emergency and social housing,
- Financial assistance,
- Temporary residency permits,
- Access to training and to decent work



3- Infographic illustrating the rate of arrests of prostituted persons and sex buyers before and after the French law (data thanks to Mouvement du Nid):


# 1 year on: state of new French law and its implementation
