France's new prostitution law:

Law enacted 13 April 2016

- Ends the repression of victims of prostitution, by abolishing the offense of solicitation.
- Ensures protection and support to all victims, including non-citizens.
- Creates access to exit pathways out of prostitution, nation-wide.
- Prohibits the purchase of sex acts.

Loi du 13 avril 2016

La nueva ley francesa sobre prostitución

Ley promulgada el 13 de abril de 2016

- Acaba la represión de las víctimas de la prostitución, abolendo el delito de solicitud.
- Garantiza protección y apoyo a todas las víctimas, incluidas las extranjeras sin papeles.
- Crea el acceso a nuevas vías de salida de la prostitución, en todo el país.
- Prohíbe la compra de actos sexuales.

French prostitution law of 13 April 2016

Description of the 23 articles of the law decriminalising prostituted persons, offering them protection and exit options, and criminalising the purchase of sex acts.



Article 1
Creation of an obligation upon internet service providers to promptly inform the competent public authorities of any content that violates the law on respect for persons, and to make public the means and measures they decide to combat such illegal activities.

Article 2
Formal integration into social workers' training programs of a module on the prevention of prostitution, and how to identify situations that may involve prostitution, pimping and human trafficking.

Article 1
Création d'une obligation pour les fournisseurs d'accès à Internet d'informer promptement les autorités publiques compétentes de tout contenu violant la loi sur la prostitution et de rendre publics les moyens qu'elles consacrent à la lutte contre ces activités illicites.

Artículo 1
Creación de una obligación para los proveedores de acceso a Internet de informar rápidamente a las autoridades públicas competentes sobre todo contenido que viola la ley en materia prostitucional y de publicar los medios tomados para luchar contra estas actividades ilícitas.

Artículo 2
Integración oficial a la carrera de trabajadores sociales, de una formación sobre la prevención de la prostitución y la identificación de situaciones de prostitución, de proxenetismo y de trata de seres humanos.
